Acknowledgement and consent that credit information may be given to a credit reporting agency.

I/We understand that the Privacy Act allows MFW to give a credit reporting agency certain personal information about me/us which I/we authorise MFW to do. The information which may be given to an agency is covered by Section 18E of the Act and includes:

- Such permitted particulars about me/us which allows me/us to be identified.
- The fact that I/we have applied for lease/credit and the amount.
- The fact that MFW is a lease/credit provider to me/us.
- Payments which become overdue more than 60 days and for which collection action has commenced.
- Advice that payments are no longer overdue.
- Cheques drawn by me/us which have been dishonored more than once.
- In specified circumstances, that in the opinion of MFW I/we have committed a serious lease/credit infringement.
- That the lease/credit provided to me/us by MFW has been discharged.

Authority for MFW to obtain certain credit information

- I/we authorise MFW to obtain from credit reporting agencies a credit report containing personal credit information for the purpose of assessing my/our application for personal credit.

- I/we authorise MFW to obtain from credit reporting agencies a credit report containing personal credit information for the purpose of assessing my/our application for commercial credit.
